**REVIEW BOARD:** The goal of the JTI Review Board is to review and select articles for publication in the Journal of Tourism Insights, an electronic journal. Resort and Commercial Recreation Association (RCRA) presenters from research-based general sessions and research symposiums will have the opportunity to submit papers. These abstracts will be reviewed via a double blind review board and reviewed paper selections will be included in the JTI. This eight member review board is chosen in consultation with the members of the RCRA Speaker Selection Committee. The Review Board will be responsible for all decisions made related to the JTI, including evaluation criteria, paper length, referencing format, etc. Submitted manuscripts will be reviewed by two editorial review board members.

Submissions to the JTI 2010 volume, must be received by December 1, 2009; Reviews completed by January 15, 2010; resubmissions must be received by March 1, 2010; with publication by April 15, 2010.

## NOTICE TO CONTRIBUTORS



The Journal of Tourism Insights (JTI) is an electronic research journal. The Journal of Tourism Insights promotes applied research in the commercial recreation, event and travel industries that will educate practitioners, educators, and students on relevant issues that enable organizations to be more effective and efficient.

To be reviewed, manuscripts must conform to the following guidelines. JTI does not have a copy editor. Thus, authors are responsible for ensuring that their submissions meet the following criteria. Since JTI is an electronic journal, special formatting guidelines must be followed in order to ensure the readability of the paper by reviewers using a wide range of word-processing software. Also, the guidelines below ensure the accurate rendering of the article on our Web site, irrespective of readers' platforms and systems, should it be accepted for publication.

1. There will be no title page for the document. Place title in **Bold** using Times or Times New Roman 16-point font with the Author information following using Times or Times new roman 10-point font on the first page of the document before the abstract section.
2. Format submissions in MSWord using 10-point Times (or Times New Roman) font for all text. Please give the document a short name when saving. Transmit the submission as an email attachment to the editor, [janes1pl@cmich.edu](mailto:janes1pl@cmich.edu)
3. Set up the page size for 8-1/2 x 11 inch paper size (US Letter). All pages must be in portrait layout. Do **not** use a landscape layout for any pages. Also, do not use page breaks or section breaks to format the manuscript (i.e., let the pages break naturally). Use Times or Times New Roman 10-point font for all content text. (excluding tables, section headings, sub-headings, and title).
4. Section headings such as (Introduction) should use Times or Times New Roman 12-point font.
5. Section sub-headings such as (*Year one*) should use Times or Times New Roman 12-point font in *Italic*.
6. Do not use headers or footers (including page numbers -- do **not** insert page numbers).
7. Endnotes/footnotes should be avoided. When they are necessary, an endnote should be used. Do **not**, however, use the endnote/footnote function in MS-Word to produce them. Instead, they must be manually entered. The endnote number should be entered in the text in brackets (e.g., "[1]") following the passage to which the footnote corresponds. They should **not** be superscripted. The endnote is then entered in a section at the end of the paper, with the heading "ENDNOTES" (all capital letters).
8. Single space all copy. Include blank lines between paragraphs, between references in the REFERENCE section, and before and after subheadings.
9. Left justify copy including title, authors names, headings and subheadings. Capitalize the initial letters of words in subheadings and Headings. References in the reference section should be left justified (not "hanging").
10. Avoid the use of symbols and other special characters (they do not reproduce consistently across different computing systems). In presentation of statistical results, refer to test statistics and parameters by spelling out the term (e.g., "alpha" instead of the character).
11. Use American Psychological Association format for references. Do **not** use a bibliographic software (such as EndNote) to produce the references. They must be manually added.
12. A *JTI* manuscript shall include an abstract. All manuscripts must reflect correct U.S. English grammar, syntax, and punctuation.
13. Embed tables in the text at the appropriate point. Content of the table will use Times or Times New Roman 10-point font while table headings will use Times or Times New Roman 12-point font.
14. Tables **must** be created with the MS-Word table editor (i.e., do **not** use tabs and spaces to create tables). Each row in the table must be created in the table editor as a row. In other words, do not use hard returns to represent rows.
15. Figures should be avoided. They should only be used if they add to the information in the paper. They should not be used if the information they contain is redundant with information reported in the text or tables. If figures are absolutely necessary, they must be prepared as GIFs and sent as attachments with the paper. The figures should not incorporate color.
16. If analysis of variance or regression methods are used in the analysis, a correlation matrix must be provided (as an appendix) that includes all variables in the analyses. The matrix must be prepared as a table.
17. Acknowledgements may be included as a note. Use the title "AUTHOR'S NOTE" or "AUTHORS' NOTE" immediately before the AUTHOR(S) BIOGRAPHY (see below).
